All sales will be conducted through ebay.com auction website adhering to the rules and regulations set forth by ebay.com. All listings will be posted and maintained by the seller upon the owners' approval of fees and prices set below and through ebay.com. Ebay.com prices are subject to change at any time. The owner will provide accurate detailed descriptions for each item. Current images will be displayed for each item listed. All item listings will be posted within a reasonable time line not to exceed 3 months between individual listings. Any false item information can be reflected upon the seller through bad feedback from buyers. Bad feedback from a buyer indicates questionable business and therefore compromises the seller. As of _____ my ebay.com feedback score is _____ and my feedback rating is 100% positive feedback for username rochris. Therefore any inaccurate item information resulting in bad feedback may result in termination of all current and future sales with the owner. All items will remain in the possession of the owner until the sale is complete unless otherwise noted by the owner. Should damage be incurred to any item while up for auction; the owner is to contact the seller immediately in order for the item to be removed from ebay.com through the end listing early form and all bids will be canceled to avoid any additional costs. All shipping, handling and pickup of items will be conducted and arranged by the seller to best serve the owner and the buyer upon receipt of payment which includes clearing personal checks. Upon auction closing all sales are final and there will be no option for returns. Owner will receive payment for sold items in full minus ebay.com fees and sellers' commission incurred no less than 24 hours and no more than 10 business days from receipt of payment from buyer. All deposits for large items will be held in good faith by the seller until final payment is received. All unsold pieces can be relisted at any time for only the additional cost of the ebay.com insertion fee. Any fees accrued due to unsold items will be accumulated into one monthly bill to be paid no later than 90 days from the date of the initial bill creation.

Sellers' Commission and Unsold item fees

10% on any item exceeding \$10,000.00

20% \$1000.00 - \$9,999.00

30% \$125.00 - \$999.00

All items sold under \$125.00 will receive a flat rate of \$25 per listing.

This fee covers the cost of time and maintenance of the auction and includes the digital photography and description of items. The seller will host a maximum of 4 images per item.

Additional images will cost \$0.50 each

All ebay.com fees for individual auctions will be billed separately in addition to above costs. Please refer to the most current ebay.com pricing sheet for exact amounts plus listing upgrades.

\$50.61 ebay final value fee (5.25% of initial \$25 [\$1.31] plus 2.75% of initial \$25-\$1000 [\$26.81]

plus 1.50% of the remaining closing value \$1000.01-closing value of \$2500 [\$22.49]

\$500.00 20% commission

Total cost \$555.41 Total profit \$1944.59
